With regard to the shares set forth under Item 4, of the 1,174,000 Shares being reported, 500 or .004% of the outstanding shares of Class A stock of Gulf Island Fabrication, Inc. are managed by NewSouth Capital Management, Inc. through a Smith Barney Fiduciary Services Program whereby accounts are placed with NewSouth for management. Although discretionary responsibility for the accounts is with NewSouth, Smith Barney retains responsibility for SEC filings should their cumulative

holdings trigger the need for 13G reporting. Of the 1,174,000 shares being reported, 750 or .006% of the outstanding shares of Class A stock of Gulf Island Fabrication, Inc. are managed by NewSouth Capital Management, Inc. through a Morgan Keegan Preferred Program ("MKPfd") whereby accounts are placed with NewSouth for management. Although discretionary responsibility for the accounts is with NewSouth MKPfd retains responsibility for SEC filings should their cumulative holdings trigger the need for 13G reporting.
